- WRJ (Docket 1020), of Mooresville Lodge No. 496 Brother failed to respond; DEFAULT entered and EXPELLED by decision of the Judge Advocate on July 7, 2025.

The Committee on Appeals recommended approving the Judge Advocate's decision, and the action was **APPROVED** by the delegates assembled.

#### Report of the Committee of Jurisprudence and Amendments Considered

The Committee on Masonic Jurisprudence recommended the following actions with regard to the Proposed Amendments to the Code (Reports Book p. 57).

- Amendment Group 1 (Insurance Management Committee): Creates a standing Committee on Insurance in Chapter 34 with defined membership, referral matters, and duties (lodges' coverage review, policy recommendations). Committee recommended referral; the delegates REFERRED the amendment to the Board of General Purposes for further consideration and clarification.
- Amendment Group 2 (Electronic Voting): Adds electronic balloting as a permitted voting method in Chapters 19 and 12, including elections of Grand Lodge officers. Committee recommended approval; the delegates APPROVED the amendment.
- Amendment Group 3 (Temporary Holding Lodge No. 777): Establishes a temporary holding lodge for displaced brethren until reaffiliation is arranged. Committee recommended referral; the delegates REFERRED the amendment to the Board of General Purposes for further consideration and clarification.
- Amendment Group 4 (Definition of Dues): Clarifies lodge dues as lodge-set amount plus Grand Lodge per capita; updates Uniform Lodge By-Laws language to avoid by-laws changes when per capita changes. The amendment was WITHDRAWN.
- Amendment Group 5 (Installed Appointive Officers): Moves Grand Chaplain to the list of appointive officers who are installed; clarifies installation discretion and updates Judge Advocate installation language. *The amendment was WITHDRAWN*.
- Amendment Group 6 (Obsolete Duty—Blank Returns): Marks Reg. 16-1.30 obsolete (annual blank returns now handled electronically). Committee recommended approval; the delegates APPROVED the amendment.
- Amendment Group 7 (Lecturer Rosters): Updates Reg. 29-7.2 to publish lecturer rosters electronically rather than in the Annual Proceedings. *Committee recommended approval; the delegates APPROVED the amendment.*
- Amendment Group 8 (Bi-Monthly/Quarterly Stated Meetings): Updates Regs. 43-2.4, 45-2, and Uniform By-Laws to allow lodges to adopt bi-monthly or quarterly schedules in by-laws without dispensation. *Committee recommended approval;* the delegates **APPROVED** the amendment.
- Amendment Group 9 (Obsolete—Waiver of Jurisdiction at Emergent): Removes obsolete prohibition relating to waivers of jurisdiction at emergent communications.

- Committee recommended the language be corrected since this pertained to a previous affirmed amendment and was otherwise superfluous.
- Amendment Group 10 (Budget Oversight & Spending Limits): Adds checks on budget modifications and over-budget expenditures (Grand Master limits; Finance Committee review; BGP 2/3 approval); aligns Grand Treasurer and Finance Committee duties. Committee recommended referral; the delegates REFERRED the amendment to the Board of General Purposes and the Committee on Finance for further consideration and clarification.
- Amendment Group 11 (Fund-Raising Variances): Empowers the Commission on Special Activities to grant variances to lodges regarding fund-raising requirements. Committee recommended approval; the delegates **REJECTED** the amendment.
- Amendment Group 12 (Defunct Lodges/Entities' Assets): Clarifies that surplus assets from defunct lodges and building corporations become property of the Grand Lodge (updating Regs. 5-1, 49-7, 31-5). Committee recommended referral; the delegates REFERRED the amendment to the Board of General Purposes for further consideration and clarification.
- Amendment Group 13 (Delinquent Dues Admin Fee): Allows lodges to assess up to \$5 administrative cost per delinquent dues notice; mirrors limit language in Reg. 43-3.17/77-8. The amendment was WITHDRAWN.
- Amendment Group 14 (Third Alternative Ballot Procedure): Modifies the optional black-cube process to require a written paper ballot (rather than show of hands) on the validity of the objection. Committee recommended referral; the delegates APPROVED the amendment.
- Amendment Group 15 (Code Amendment Process): Codifies submission, publication, review, and referral steps (deadlines; website posting; Code Commission review; MJ referral by March 31). Effective Oct. 1, 2025. Committee recommended referral; the delegates REFERRED the amendment back to its proposers and the Code Commission for further consideration and clarification.
- Amendment Group 16 (Specific Masonic Offense—Re-petition Interval): Aligns offense language with six-month re-petition rule (instead of one year) after rejection. Committee recommended the language be corrected since this pertained to a previous affirmed amendment and was otherwise superfluous.
- Amendment Group 17 (Installation Date): Moves the earliest permissible installation date for Grand Lodge officers to the **first** Saturday in November. *The amendment was WITHDRAWN*.
- Amendment Group 18 (Deputy Grand Lecturer): Creates Deputy Grand Lecturer roles (Areas 1–5) with qualifications and duties to support the Grand Lecturer and Board of Custodians. Committee recommended approval; the delegates APPROVED the amendment.
